The Chicago metropolitan area contains five out of the 10 most concentrated manufacturing zip codes in America. But external factors continue to place Illinois manufacturers in a precarious position. In Illinois, we pay some of the highest sales, property and income taxes in the United States. In a global economy, Illinois-based manufacturers compete nationally and internationally for work. Tax demands, in addition to business expenses, may determine whether bids are won or lost. Losing bids risk good-paying jobs and the generous economic benefits resulting from Illinois-based manufacturing.

#### Mark Mueller for Mayor

Mark Mueller is a retired Hoffman Estates Police Lieutenant who has lived or worked in Hoffman Estates his entire life.

From 1993 until recently retiring to run for mayor, Mark served and protected our village as a member of the Hoffman Estates Police Department. Rising from the patrol division to Lieutenant, Mark received two life-saving awards and countless letters of appreciation from residents. He also led public relations for the department for 4 years where he coordinated community information and led the citizens police academy.

Mark has extensive knowledge of complex budgets and has found innovate ways to save money. Mark oversaw the police training budget and community relations budget where he successfully reduced expenses while maintaining staff. While in patrol, Mark assisted with the patrol budget including planning, spending, and bidding.

The youngest of the 6 children in his family, Mark grew up in the "Parcel C" area and attended St. Hubert School. He graduated from Conant High School where he was a student-athlete. After high school, Mark attended Harper College and earned a degree in Criminal Justice.

Prior to joining the Hoffman Estates Police Department, Mark worked for the Village of Wheeling as a community service officer. While with the Wheeling Police Department, one of his commanders, who lived in Hoffman Estates, asked Mark to help coach football with the Hoffman Estates Athletic Association. Mark accepted, and since that time nearly 30 years ago, Mark has continued to coach football and has served as the President of the Hoffman Estates Athletic Association.

Mark founded the Law Enforcement Athletics Program which allows atrisk children to play football as well as participate in cheerleading and other activities. He served as President of the Chicagoland Pop Warner football organization, which serves 30 regional organizations. Mark also started the lacrosse program at Hoffman Estates High School and coached High School level lacrosse for 14 years at Hoffman Estates High School, Barrington High School, Saint Viator, and Schaumburg High School.

Mark and his wife, Jeanne, have two daughters who both attend the University of Iowa. Jeanne is also a frontline hero, working as a nurse at Loyola University Medical Center in Maywood. They attend St. Hubert's Church in Hoffman Estates.
